#### 5. TECHNICAL REQUIREMENTS:

SEWER: Under no circumstances shall any new fixture be installed in a building lower than the curb elevation or street centerline elevation, whichever is higher, unless special precautions are incorporated into the new fixture from the sanitary sewer main form high flow or blockage. Lateral form the house to the main shall be cast iron or PVC. The connection to the main shall be through an approved wye or saddle.

# A REPRESENTATIVE OF THE AUTHORITY SHALL BE PRESENT AT TIME OF TAPPING INTO THE AUTHORITY MAIN.

A riser cap and trap shall be installed one foot inside the curb.
